

2026 PSO New Homes Rebate Guidelines

Thank you for your interest in Public Service Company of Oklahoma's (PSO) New Homes Rebates. The 2026 New Homes Rebates applies to homes completed after January 1, 2026. Each home can receive a maximum of \$7,500 in rebates. Contact an Account Manager for more details about rebates. Rebate funds are limited, and an allocation process may be used for the 2026 program year.

PSO Power Forward Package

PSO is offering one simple rebate of \$800. The Power Forward Package must be verified by a HERS Rater. All homes must pass a thermal bypass inspection. As part of the inspection, each home must pass all requirements of an ENERGY STAR v2 Thermal Bypass Checklist (TBC). A major component of the TBC is air barrier and thermal alignment. Examples include air blocking behind bathtubs on exterior walls and using a backing material on insulated knee walls. Please contact your HERS Rater if you have questions about properly installing insulation and air barriers to meet the TBC requirements. Foam attic applications must fully cover the roof rafters with a minimum of one inch on and around the rafters with cavities meeting an R-21 minimum.

HVAC Equipment Rebate

PSO is offering a separate rebate for HVAC equipment (paid per system) that meet either 15.2, 17.2, or 19.1 SEER2 as rated by AHRI. Minimum EER2 ratings must meet ENERGY STAR certification guidelines. See the Home Rebates Guidelines for Single & Multiple Upgrades for more details.

For the 2026 program year, the HVAC rebate is independent of the Power Forward Package and submitted through the Single Upgrade rebate program. The HVAC company must be registered as a participating service provider through the Single Upgrade registration process.

ENERGY STAR Heat Pump Water Heater (HPWH)

Homes equipped with an ENERGY STAR Heat Pump Water Heater are eligible for a \$1,500 rebate. The HPWH must meet minimum 2.5 energy factor (EF) and 40 gallon capacity. The HPWH earning this rebate is not eligible for any other PSO HPWH rebates offered in other programs.

The HPWH must meet all local and state building codes, including permits and inspections, and must meet manufacturer recommendations for minimum cubic feet for ventilation. Homebuilder should identify necessary electrical considerations based on the manufacturer's requirements and applicable codes.

ENERGY STAR NextGen Certification

Homes that meet the ENERGY STAR NextGen v3.1 certification standards for Single Family New Homes (SFNH) will earn an additional \$2,000 incentive bonus. All program requirements and checklists must be completed and submitted for full ENERGY STAR certification and available at PSO's request.

Electric Vehicle Ready Plug Rebate

Homes that include a minimum 32 amp devoted circuit attached to a NEMA 14-50 plug in the garage, ready for a level 2 EV charger are eligible for an additional \$50 rebate.

ENERGY STAR Certification Support

PSO will continue to recognize builders that meet current ENERGY STAR v3.1 & 3.2 certification standards. Support will be offered through special recognition on www.PowerForwardwithPSO.com website and during the annual parade of homes. Additional field training is available to sales and marketing staff upon request.

Quality Assurance Inspections

Homebuilder and HERS Rater participation in the PSO New Home Rebates program is dependent on following these guidelines and includes quality assurance (QA) checks from ICF or ADM Associates. These QA checks can occur in the form of on-site inspections (at any point in the construction process), floor plan reviews, permit reviews, code compliance, or any other check that ensures the PSO rebate is appropriately paid for energy saving measures.

Noncompliance found during QA checks could result in mandatory remediation, probation, removal from the program, and/or forfeiture or repayment of PSO rebate funds.
